



Community

Ending the HIV epidemic isn't something one organization can do alone. It requires everyone—clients, family, friends, neighbors, volunteers, donors, government and community partners—to work together as an interconnected system. Here are just a few examples of the many ways community connections and collaborations expand our reach, deepen our impact and contribute to a future where health and well-being are accessible to all.



Ol Hamilton County Public Health partnered with Caracole to host the first local fixed-site, evening syringe service program in our region in 2019. What started as a small syringe exchange has since grown to a comprehensive harm reduction program with multiple agencies participating, offering testing, education, safer use supplies, substance use treatment referrals, comprehensive hepatitis treatment, food and medical care.



O3 Multiple public libraries partnered with Caracole to honor World AIDS Day 2023 with an awareness campaign highlighting materials about HIV. During the week-long campaign, The Cincinnati Public Library of Hamilton County branches, The Mercantile Library, The Lane Libraries and The University of Cincinnati Health Sciences Library displayed resources and information on HIV past and present—from novels and memoirs to plays, movies and documentaries—to help fight HIV stigma, fear and discrimination in

our community.



O4 Our testing van is our mobile community outreach tool promoting HIV testing and awareness in multiple locations throughout the region. In an average year, more than 36% of our HIV tests take place on our van. Thanks to the generous contributions of Duke Energy, The Joint Women's Collaborative of Wyoming Foundation and the Northside Community Council, our plain white van got a stylish makeover in 2023. The new wrap protects the van against weather, road debris and sun damage, and, most importantly, provides a welcoming, visible presence in the community.

02 Northsiders Engaged in better known as NEST, received funding from the City of Cincinnati's Neighborhood Business District Improvement Program for Northside's REFRESH Program. Seventeen locations, including Caracole's office building on Hamilton Avenue, were selected for exterior improvements to enhance Northside's business district. Artist Lindsay Nehls painted an inspiring, vibrant mural (pictured on our front cover), which transforms our building's southside into a celebration of our Northside community. O5 NeighborHub Health (formerly known as Cincinnati Health Network) has had a home at Caracole since 2018. Their Peter T. Frame Primary Care Clinic inside the Caracole office provides a variety of primary care opportunities including multi-panel STI testing, wound care, medically assisted substance use treatment, PrEP prescriptions, mental health medications and more. The clinic's caring and sensitive staff shine during our syringe services program, offering no-barrier care to people who are otherwise reluctant to engage the medical establishment.



Our friends at St. Columban Church in Loveland, Ohio organize a giving tree every year to spread holiday cheer to the community. For 20 years, Caracole has been lucky to be a part of this wonderful tradition of donating essential household items—like space heaters, personal care items, bedding, new coats and small appliances—to Caracole clients.



O7 The Ending the HIV Epidemic Advisory Board brings together local African American community leaders from churches, businesses and medical organizations to advise Caracole on its marketing, messaging and geographic targeting. The wisdom of these volunteers has helped Caracole improve its relevance and cultural competence in reaching at-risk communities.




O9 Santa Maria Community
Services has been Caracole's home
away from home in Price Hill, and
has been key to efforts to engage the
Spanish-speaking community. Their
staff provides on-site translating for
our HIV health educators, and they've
also assisted in honing our Spanish
language brochures and educational
materials.



Reduction Collaborative serving
Butler, Brown, Clermont and
Clinton counties has helped
expand Caracole's reach outside
Hamilton County, especially Butler
County, where our concentrated,
coordinated efforts have succeeded
in reducing a significant cluster of
new HIV diagnoses among people
who inject drugs. They are also
helping us obtain Narcan and other
supplies at low- or no-cost.

TESTING & OUTREACH



In 2023, we visited 71 unique community sites in our region to reach populations most at risk for HIV.

We performed 1,177 in-person HIV tests:

• 11 individuals tested positive for HIV (<1%)

We distributed:

- 925 HIV self-test kits
- · 45,161 condoms
- · 2,376 lubricants
- 6,312 safer sex kits
- · 1,063 fentanyl test strips

We provided 118 individuals with PrEP assistance and navigation. 18% of these were new participants in the program.

In December 2023, we celebrated World AIDS Day with our PrEP It Up Party, where we engaged 350 people about the benefits of PrEP and how to access it in our community. Attendees also took home hundreds of condoms, safer sex kits, fentanyl test strips and HIV self-test kits.

SYRINGE SERVICES PROGRAM¹



Out of 4,916 visits, we served people from 172 zip codes in our region and distributed:

- 343,245 syringes (and collected 203,636)
- · 2.158 doses of naloxone
- · 4,755 fentanyl test strips

HARM REDUCTION VENDING MACHINE




729 participants accessed 60 HIV self-test kits, 18,493 safer-use and safer sex supplies from the machine, including 781 sharps containers and 19,941 doses of naloxone. Based on participant re-enrollment data, naloxone from the machine was used to reverse an overdose 2,460 times.²



HOUSING FIRST



Our Greater Cincinnati community benefitted from more than \$1.3 million in direct housing assistance from Caracole in 2023. These funds ensured people living with HIV could stay in their homes and work toward their health and well-being goals, and it also strengthened our local economy.

LONG-TERM ASSISTANCE



We provided safe, affordable homes to 195 people in 147 households. 84% of the people living with HIV in those households⁴ were virally suppressed, a key indicator of health and a major accomplishment for those facing multiple barriers that hinder their ability to engage in health care.

CARACOLE HOUSE



A low barrier, site-based, permanent housing program, Caracole House serves individuals living with HIV who are precariously housed or experiencing chronic homelessness. We offer private units for single adults and provide supportive services and case management for each resident. In 2023, a second case manager joined the Caracole House team so that clients' medical and housing stability needs could be more fully addressed. Regular apartment inspections facilitated conversations about how to maintain a home. The housing case managers also work on graduation planning and help clients identify a next home while also setting the client up for success with financial and social support.

SHORT-TERM ASSISTANCE

We prevented homelessness for 22 households by providing \$55,946 in short-term rent and utility assistance. With this temporary support, these clients were able to stabilize their health and finances, after facing challenges due to income loss (68%), illness/ hospitalization (23%) or other emergencies.





CLIENT SERVICES



We served 1,416 clients in case management:1

- · 88% of our clients^{1,2} are virally suppressed
- 96% of our 340B pharmacy program clients^{1,2} are virally suppressed

Our pharmacy program filled 6,939 prescriptions and we paid \$464,156 in pharmacy co-pays on behalf of our clients. The cost to clients through this program was \$0.

We received 1,411 calls to our intake line, resulting in:

- · 359 referrals to Caracole case management
- · 229 referrals for housing assistance
- 169 requests for prescription-assistance resources information
- 45 individuals newly diagnosed with HIV being linked to services
- · 68 referrals for medical care

SUPPORT GROUP



Pozitive Attitudes, an in-person social support group for people living with HIV lead by Caracole and Equitas Health, saw a 40% increase in participation in 2023. The monthly meetings help to decrease social isolation among participants and provide a safe space to candidly share their experience of living with HIV.

Motivational Interviewing is an evidence-based communication approach used by case managers to inspire people to uncover the internal motivation they need to make positive change. In 2023, our case management team completed comprehensive formal training, including advanced instruction in the method. Equipped with these skills, our case managers empower clients to embrace change by drawing out their own meaning, importance and capacity for growth.


