



How to Report Your Concerns

We want to make sure that you and your family are treated with respect. **If we have not lived up to this promise**, we need you to let us know. Here is how to report a problem:

- 1. Share your concerns with your Case Manager or Housing Specialist.**
- 2. Contact a supervisor** if you feel that your questions or concerns have not been addressed, or if you do not feel comfortable talking with your Case Manager or Housing Specialist.

- 3. Contact the Chief Program Officer** by phone or in writing if you are not satisfied after speaking to a supervisor. After hearing from you, she will contact you within three business days to talk about the problem.

- 4.** The Chief Program Officer will notify the **Chief Executive Officer** after talking with you if the problem is not resolved. The Chief Executive Officer or her delegate will contact you within three business days after that to address your concern.

- 5.** You also have the right to **make a complaint outside our organization**. If you are not sure who to speak to, the Chief Executive Officer or Chief Program Officer can help.
